**PLACING OF NEW SHARES UNDER GENERAL MANDATE**

**THE PLACING**

On 8 February 2010, after trading hours, the Placing Agent and the Company entered into the Placing Agreement pursuant to which the Company has conditionally agreed to place, through the Placing Agent on a best effort basis, up to 250,000,000 Placing Shares to not fewer than six Placees at a price of HK\$0.19 per Placing Share.

The maximum of 250,000,000 Placing Shares under the Placing represent (i) approximately 14.04% of the existing issued share capital of the Company of 1,780,600,590 Shares as at the date of this announcement; and (ii) approximately 12.31% of the Company's issued share capital of 2,030,600,590 Shares as enlarged by the Placing Shares.

On the assumption that all Placing Shares are fully placed, the gross proceeds arising from the Placing will be approximately HK\$47.5 million and the net proceeds arising from the Placing will amount to approximately HK\$46.6 million which is intended to be used for settlement of part of the acquisition price for the Acquisitions and general working capital of the Group. The net proceeds raised per Placing Share upon the completion of the Placing will be approximately HK\$0.186 per Placing Share.

The Placing is conditional upon, among other things, the Listing Committee of the Stock Exchange granting or agreeing to grant the listing of, and permission to deal in, the Placing Shares.

**Completion of the Placing is subject to the satisfaction of the conditions precedent in the Placing Agreement. As the Placing may or may not proceed, Shareholders and potential investors are advised to exercise caution when dealing in the Shares.**

## **THE PLACING AGREEMENT**

**Date:** 8 February 2010, after trading hours

**Issuer:** The Company

**Placing Agent:** Luen Fat Securities Company Limited

The Placing Agent has conditionally agreed to place a maximum of 250,000,000 Placing Shares on a best effort basis. The Directors are of the view that the placing commission payable to the Placing Agent pursuant to the Placing Agreement is at normal market rate, and therefore it is fair and reasonable.

### **Placees**

The Placing Agent agreed to place the Placing Shares on a best effort basis, to no less than six Placees (whom and whose ultimate beneficial owners, the Placing Agent reasonably believes to be independent professional, institutional or other private investor(s) who (i) are not Connected Persons of the Company; and (ii) are independent of each other, the Company and its Connected Persons during the period from the date of the Placing Agreement up to the completion of the Placing.

### **Placing Shares**

The maximum number of 250,000,000 Placing Shares under the Placing represent (i) approximately 14.04% of the existing issued share capital of the Company of 1,780,600,590 Shares as at the date of this announcement; and (ii) approximately 12.31% of the Company's issued share capital of 2,030,600,590 Shares as enlarged by the Placing Shares.

### **Ranking of Placing Shares**

The Placing Shares will, upon issue, rank pari passu in all respects with the Shares in issue on the date of allotment and issue of the Placing Shares.

### **Placing Price**

The Placing Price of HK\$0.19 represents (i) a discount of approximately 18.1% to the closing price of HK\$0.232 per Share as quoted on the Stock Exchange on the Last Trading Day; (ii) a discount of approximately 19.3% to the average closing prices of HK\$0.235 per Share for the last 5 consecutive trading days up to and including the

Last Trading Day; and (iii) a discount of approximately 20.4% to the average closing prices of HK\$0.239 per Share for the last 10 consecutive trading days up to and including the Last Trading Day. After deduction of relevant expenses of Placing, the net placing price per Placing Share is HK\$0.186.

The Placing Price was determined with reference to the prevailing market price of the Share and was negotiated on an arm's length basis between the Company and the Placing Agent. The Directors consider that the terms of the Placing are on normal commercial terms and are fair and reasonable based on the current market conditions and the Placing is in the interests of the Company and the Shareholders as a whole.

### **General Mandate**

The Placing Shares will be issued under the General Mandate granted to the Directors by a resolution of the Shareholders passed at the AGM subject to the limit of up to 20% of the issued share capital of the Company as at the date of the AGM, (i.e. 338,520,118 Shares, representing 20% of 1,692,600,590 Shares in issue as at the date of the AGM). Up to the date of this announcement, 88,000,000 shares have been issued under the General Mandate, leaving a balance of 250,520,118 Shares to be dealt with under the General Mandate. The Placing is not subject to Shareholders' approval.

### **Conditions of the Placing**

Completion of the Placing is conditional upon:

- (i) the Listing Committee of the Stock Exchange granting or agreeing to grant the listing of, and permission to deal in, the Placing Shares; and
- (ii) the Placing Agreement not being terminated in accordance with the terms of the Placing Agreement, including provisions regarding force majeure event.

### **Termination**

The Placing Agent may, in its reasonable opinion, after consultation with the Company, terminate the Placing Agreement by notice in writing to the Company at any time up to 6:00 pm on the date of immediately preceding the Completion Date if it comes to the notice of the Placing Agent that:

- (i) the Placing Shares cannot be issued and allotted in accordance with the Memorandum and Bye-laws and with all relevant laws of Hong Kong and Bermuda and shall at the Completion Date, be free from all liens, charges,

encumbrances and third-party rights of whatsoever nature and together with all rights attaching thereto at the Completion Date; and

- (ii) the Company does not have full power, authority and shareholders' consent to issue the Placing Shares.

Upon termination of the Placing Agreement pursuant to grounds as stated above, all liabilities of the Company and the Placing Agent under the Placing Agreement shall cease and determine and no party shall have any claim against the other party in respect of any matter or thing arising out of or in connection with the Placing Agreement save in respect of any antecedent breach of any obligation under the Placing Agreement.

### **Completion of the Placing**

Completion of the Placing will take place within fourth Business Days after the fulfillment of the conditions as set out in the Placing Agreement by not later than 1 March 2010 or such later date to be agreed in writing between the Company and the Placing Agent.

**Completion of the Placing is subject to the satisfaction of the conditions precedent in the Placing Agreement. As the Placing may or may not proceed, Shareholders and potential investors are advised to exercise caution when dealing in the Shares.**

### **REASONS FOR THE PLACING AND USE OF PROCEEDS**

The Board considers that the Placing represents a good opportunity to broaden the Shareholders base and to raise capital for the Company for its future business developments. The Directors consider that the Placing is fair and reasonable and in the interests of the Company and the Shareholders as a whole.

On the assumption that all Placing Shares are fully placed, the gross proceeds arising from the Placing will be approximately HK\$47.5 million and the net proceeds arising from the Placing will amount to approximately HK\$46.6 million which is intended to be used for settlement of part of the acquisition price for pursuing the project of exploiting the Iron Ore Mine upon and the Sale Share completion of the Acquisitions (as defined in the Announcements, which terms are defined below) and for general working capital of the Group.

As mentioned in the Company's announcements (“**Announcements**”) dated 3 November 2009 and 14 January 2010 respectively, the Company has entered into acquisition agreements for the Acquisitions, which are subject to the shareholders’ approval. Part of the proceeds arising from the Placing would be applied to the settlement of the acquisition prices for the Acquisitions in relation to the Iron Ore Mine and the Sale Share.

The net proceeds raised per Placing Share upon the completion of the Placing will be approximately HK\$0.186 per Placing Share.

### **FUND RAISING ACTIVITIES IN THE PAST TWELVE MONTHS**

Reference is made to the Company’s announcements dated 27 May 2009, 29 June 2009, 21 July 2009, 24 August 2009 and 5 February 2010. As set out in the Company’s announcements dated 29 June 2009, 21 July 2009, 24 August 2009 and 5 February, the Company had conducted and completed four tranches of placing of 88,500,000 new Shares at the placing price of HK\$0.397 per new Share, 111,660,000 new Shares at the placing price of HK\$0.30 per new Share, 81,000,000 new Shares at the placing price of HK\$0.25 and 88,000,000 shares at the placing price of HK\$0.26 under the General Mandate (the “Placings”), respectively. The aggregate net proceeds of approximately HK\$109.73 million arising from the Placings have been used or will be used for settlement of part of the acquisition prices for pursuing the Acquisitions as disclosed in the Announcements and for the general working capital of the Group.

Save for disclosed above, the Company has no other fund raising activities in the past twelve months.

The Group is principally engaged in (i) manufacturing and sales of pharmaceutical products and (ii) iron mining business.
